


Monitoring EU Agri-Food Trade: Developments in 2019



2019: Record growth for EU28*) agri-food trade

For the year 2019, EU28 agri-food trade value reached a record of EUR 270.5 billion, with EU exports worth EUR 151.2 billion, corresponding to a strong growth in export values by 10% compared to 2018.

Strong increase in exports to China

In 2019, the main export destinations for EU28 products (in EUR billion) were USA (24.3), China (15.3), Switzerland (8.5), Japan (7.6) and Russia (7.2). These destinations account for over 40% of total EU agri-food exports.

The biggest export gains in 2019 (in EUR billion, % change from 2018) were achieved in exports to China (+4.2; +40%), the USA (+2.07; +9%), Japan (+1.01, +15%), Russia (+0.57, +9%), Egypt (0.48; +32%), Turkey (+0.44, +14%) and Ukraine (0.417, +20%). However, for the last 2 months of 2019, EU agri-food exports to USA saw a marked drop for certain products as a result of US tariffs.

Exports in 2019 (in EUR billion, % change from 2018) decreased most for Hong Kong (-0.4; -11%), Libya (-0.17, -15%), Algeria (-0.12, -5%), Angola (-0.1, -15%) and Lebanon (-0.09, -8%).

Pork, wheat and spirits lead export growth

For specific products, exports grew the most in 2019 (in EUR million, % change from 2018) for pork meat, fresh, chilled and frozen (\pm 2 359; \pm 49%), wheat (\pm 1 747; \pm 48%); spirits and liqueurs (\pm 1 125; \pm 10%), milk powders and whey (\pm 680; \pm 17%) and offal, animal fat and other meats, fresh, chilled and frozen (\pm 637; \pm 24%). Other important increases were recorded for wine, vermouth, cider and vinegar (\pm 589; \pm 5%), food preparations (\pm 532; \pm 9%), pasta, pastry, biscuits and bread (\pm 510; \pm 10%), and cotton, flax and hemp (\pm 463; \pm 51%).

The impressive growth of exports for pork meat was driven primarily by demand from China (+230%), whereas for wheat exports increased in particular to Egypt, Morocco, Turkey and China.

On the other hand, in 2019 exports experienced the largest drop in value terms (in EUR million, % change from 2018) for the following products: beet and cane sugar (-523; -48%), olive oil (-125; -5%), raw hides and skins (-114; -8%), vegetable oils other than palm and olive oil (-104; -5%) and fatty acids and waxes (-102; -17%).

While EU28 agri-food imports rose slightly in 2019, a record growth came from Ukraine

Agri-food imports from third countries in 2019 accounted for EUR 119.3 billion, i.e. an increase of 2.5% compared to 2018.

The five main origins for EU28 agri-food imports over the past 12 months remain the same countries than in previous years, accounting for more than 35% of total agri-food imports, namely: the USA (11.8), Brazil (11.6), Ukraine (7.4), China (6.1) and Argentina (5.0). High levels of imports also continue to originate from Switzerland (4.7), Turkey (4.7) and Indonesia (4.1).

The value of imports (in EUR million, % change from 2018) increased most significantly from Ukraine (+1 757; +31%), Canada (+451; +23%), China (+418; +7%), Peru (+334; +15%) and Serbia (+279; +25%).

However, on the year-on-year basis, the value of agrifood imports in 2019 (in EUR million, % change from 2018) fell most from the USA (-290; -2%), Indonesia (-290; -7%), Brazil (-288; -2%), Australia (-286; -14%) and New Zealand (-190; -8%).

Imports into the EU28 of tropical fruit and oilseeds other than soyabeans recorded the biggest rise in 2019

Looking at product categories, the highest increases in import values in 2019 (EUR million; % change since 2018) were recorded for tropical fruit (+752; +6%), oilseeds, other than soya beans (+747; +21%), vegetable oils other than palm and olive oil (+660; +30%), cereals other than wheat and rice (+461; +12%) and vegetables, fresh, chilled and dried (+335; +7%). Other significant increases were also recorded for beet and cane sugar (+327; +50%) and ethanol (+293; +90%).

On the other hand, in 2019 imports fell back most (in EUR million, % change from 2018) for palm and palm kernel oil (-612; -11%); citrus fruit (-282, -13%), olive oil (-215; -36%), sheep and goat meat (-208, -20%) and oilseeds other than soya beans (-226; -4%). Other reduction were also recorded for wheat (-167; -13%), butter (-37; -38%) and wool and silk (-102; -10%).

With EU28 agri-food exports growing more than imports into the EU, the positive trade balance grew in 2019 by 52%

With the strong export performance in 2019 and the slight growth in imports, the trade surplus grew by EUR 10.9 billion, that is, 52% higher than in 2018, and has reached an all-time high of EUR 31.9 billion.
